## Buying a Scrap Vehicle without a Title in Iowa

Advocacy is the means by which a group of like-minded folks go to their legislative body to promote an idea that should better their state pertaining to the subject that unified the folks in the first place. Such is the case when the Iowa Auto Recycler responded to an opportunity to develop a process by which the legal owner of a vehicle could get rid of the car from the “back forty” without a title or the need to embark on a lengthy process with the local police department.

**af-fi-da-vit** [*afə'dāvit*] *noun*  
 1. a written statement confirmed by oath or affirmation, for use as evidence in court.

The Iowa Affidavit Rule is a tool to protect consumers from fraud when dealing with black market scrapper. The new tool is **an affidavit sale of a vehicle in Iowa to a licensed automotive recycler** by the rightful owner of the car or truck without a title. The Iowa Automotive Recyclers worked with Auto Data Direct, an industry expert, the scrap metal recyclers and the Iowa Department of Transportation to craft a bill that the Governor signed in April 2015.

The new law has yet to be written into rule but still became effective on January 1, 2016.

In response, IAR developed a sample form to help recyclers capture the required and recommended data to make the acquisition with maximum protection to the buyer. The form can be downloaded from the Iowa Automotive Recyclers website at

The idea was to create a legal avenue for these vehicle as a means to protect consumers from fraud by the black market operators who may never retire the VIN from the system as is required by the rule. Recyclers that buy a vehicle on an affidavit of ownership must report the vehicle to the National Motor Vehicle Titling Information System or NMVTIS as **CRUSHED** within two business days. The vehicle can never again be rebuilt or sold as road worthy.

President Andy Wilken called the meeting to order at 9:05 a.m.

**NMVTIS/Affidavit Rule Writing** – Sue said we have not received the rule draft yet. Sue does not think the written rules will be available until after the law goes into effect on January 1, 2016, Jim P., IAR Lobbyist, agreed. Sue/Jim said we can take cars without title per the new law even without the rules being written. Jim said that any necessary rule changes will probably have to be done by lobbying the House and Senate. One such change would be making lien check mandatory and requiring the affidavit of ownership in writing. Once the written rule is filed then the public will have 20 days +/- to comment. We may be able to view the draft prior to publication but the time is getting very short so that seem unlikely now. Jim suggested making a subcommittee of the legislative committee to work on our response with a quick turnaround.

Sue has been working on an affidavit form in anticipation of the DOT not developing one. Sue went through information to be included on the form and Jim added his suggestions. It was decided that the form will be refined then Jim will do a final review. That final standardized form will be offered to the IAR members and scrap metal facilities and also to the DOT to adopt.

**OEM Data Bill/Amendment** - Mike Swift (ARA President) recapped the news about the amendment on the transportation bill that just passed which was put forth by the ARA. The bill will compel automakers to provide VIN data on parts, specifically recalled parts, in batch form that will be able to be integrated into inventory management systems so that recalled parts will be flagged at point-of-sale. This amendment will also provide more detailed info on all parts, not just recalled ones. The access to this data will make parts matching to customer's needs much better and safer.

## OSHA's Reporting and Recordkeeping Rule Posting Reminder

The U.S. Department of Labor's Occupational Safety and Health Administration (OSHA) updated the recordkeeping rules for injury and illness data recorded by employers effective January 2015. **Information previously recorded and kept on-site in case of inspection now must be reported to OSHA directly or via your state agency.**

**Since that update the agency has now made the online form available.**

The final rule will allow OSHA to focus its efforts more effectively to prevent fatalities and serious work-related injuries and illnesses. The final rule will also improve access by employers, employees, researchers and the public to information about workplace safety and health and increase their ability to identify and abate serious hazards.

**As of January 1, 2015, all employers must report the following events to OSHA:**

**All work-related fatalities within 8 hours.**

**All work-related inpatient hospitalizations, all amputations and all losses of an eye within 24 hours.**

Employers must report work-related fatalities within **8 hours of finding out about it**. Only fatalities occurring within 30 days of the work-related incident must be reported to OSHA. For any in-patient hospitalization, amputation, or eye loss **employers must report the incident within 24 hours of learning about it.**

### Recording requirements:

The new rule retains the **exemption for any employer with ten or fewer employees from the requirement to routinely keep records**. Employers with ten or more employees had generally been using the OSHA Form 300 to record individual injuries or illnesses occurring in the workplace. These incidents were then summarized on the annual OSHA 300A Log for posting in an employee accessible area.

### Reminder:

**Post the OSHA 300 A Log (summary) February 1 until April 30th each year.**

Those processes will remain the same with the addition of reporting an individual incident to OSHA directly or through the state agency such as IOSH in Iowa.

In **IOWA** employers may make reports required by using at least one of the following methods:

**The Iowa compliance date for reporting under the new rule was January 14, 2015.**

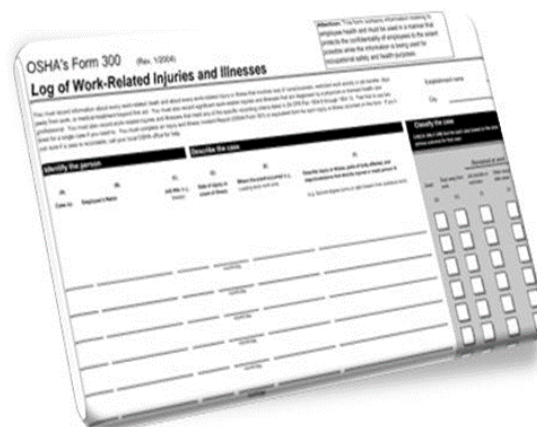

## OSHA's Reporting and Recordkeeping Rule Posting Reminder

### OSHA 300 Form

OSHA Form 300 is used to log work-related injuries and illnesses and to note the extent and severity of each case. When an incident occurs, use the OSHA 300 Form or Log of Work-Related Injuries and Illnesses to record specific details about what happened and how it happened. By using the OSHA produced Excel format the incidents reported on the Form 300 will automatically be tallied in the Form 300A for the annual summary.

### OSHA 301 Form

OSHA Form 301 is also used to record work-related injuries and illnesses but is an incident specific form. A new Form 301 would be completed for each injury or illness incident. The information on Form 301 is what is required to be reported to OSHA or the state program under the updated regulation effective January 2015.

### Post OSHA 300A Log

The Summary Form 300A shows the totals of recorded events for the year in each category. At year-end, post the 300A Log in a visible location so that employees are aware of the injuries and illnesses occurring in their workplace. Post the OSHA 300A log in an employee accessible area such as near the Department of Labor required postings.

Keep a separate log and summary for each physical location that is expected to be in operation for one year or longer.

**Listing a case on the log does not mean that the employer or worker was at fault or that an OSHA standard was violated.**

Work-related injuries or illnesses occur in the workplace due to an event or exposure in the work environment. Record injuries or illnesses that result in death, loss of consciousness, days away from work, restricted work activity or medical treatment beyond first aid as well as those that meet the additional criteria (as detailed in OSHA guidance documents) such as needle stick injuries, TB infection, medically removed employees or criteria hearing losses.



**Employers will be required to report any work-related fatalities within 8 hours and injuries within 24 hours.**

# Battery “Dangerous Goods” Regulation

## Update HazMat Training to Ship Li Ion Hybrid Batteries

A Hazardous Material (HazMat) means a material, determined by the Department of Transportation, capable of posing a risk to health, safety and property when transported. HazMat includes hazardous substances, dangerous goods, hazardous waste, and elevated temperature materials.

Of all the shippers' responsibilities, the requirement to properly classify a hazardous material is very important. It is from the proper identification of the hazardous materials that the other requirements are based. For automotive recyclers training and certification, the hazardous materials are:

**Airbag Inflators:** Consisting of a casting containing an igniter, a booster material and a gas generate. **Airbag Module:**

Consisting of the airbag inflator plus airbag assembly. **Seat belt pre-tensioner:** Contains similar hazardous materials and is used in the operation of a seat belt restraining system in a motor vehicle.

**Lithium-ion Batteries:** All types of lithium batteries were recently designated as “Dangerous Goods” with shipping restrictions. Automotive large format batteries for electric and hybrid vehicles will be either Nickel Metal Hydride or Lithium-ion batteries.

Lithium-ion batteries have higher energy densities than lead-acid batteries or nickel-metal hydride batteries. Having a high energy density means that the battery can store more electricity in the same size cell. It follows, then, that with the same amount of electricity it is possible to make the battery smaller. This is why the lithium-ion battery is ideal for being a

battery on an electric vehicle, since it is compact and lightweight. A battery with high capacity is indispensable for improving acceleration and fuel efficiency for hybrid vehicles.

The hybrid Li-ion battery delivers twice the power compared to similarly sized conventional cells. As the output of the battery increases, so too does the acceleration. It also more efficiently stores energy during deceleration, further improving fuel efficiency.

Most Lithium batteries are considered hazardous materials (also called dangerous goods,) and are subject to regulations issued by the DOT and International Civil Aviation Organization (ICAO). The DOT’s Pipeline and Hazardous Materials Safety Administration (PHMSA) works to ensure the safe transportation of hazardous materials – including batteries – shipped by highway, rail, water, or air.



The regulations pertaining to the transportation of lithium batteries have changed recently. The new regulations also apply to cells and batteries that are packed with or contained in equipment.

Shippers of larger cells and batteries must comply with specific labeling, marking, packaging, shipping paper, and employee training requirements as is the case in HazMat shipping of airbag for recyclers.

The DOT HazMat regulations prohibit the transport of lithium metal batteries on passenger-carrying aircraft and requires specific markings on packaging that contain small, consumer-type lithium metal batteries thus the reason why you cannot put lithium batteries in checked luggage. A “cargo aircraft only” label must be placed on packaging containing larger cells and batteries that are shipped as hazardous materials. For more information visit the web site at <http://hazmat.dot.gov>.

HazMat must be prepared for shipment in a very specific manner. HazMat shipping papers provide information on shipper/receiver name and address, HazMat description, DOT proper shipping name, quantity, emergency response information and certification and signature. If you ship or deliver HazMat in your own vehicle, such your own pick-up truck or delivery van, then you must comply 100% with these regulations. Under this scenario no placards are required on the vehicle. *Continued on page 15...*

# Battery "Dangerous Goods" Regulation

## Update HazMat Training to Ship Li Ion Hybrid Batteries

### HAZMAT DESCRIPTION

**Hazardous Class or Division:** Refers to the category of hazard assigned to a hazardous material. Air bag modules, air bag inflators and seatbelt pre-tensioners can be classified as Class 9 or 2.2 Hazardous Materials depending on the ignitor material.

**Lithium-ion batteries can be classified as Class 9.**

**UN Number:** UN stands for United Nations. The UN number contains 4 digits and refers to packaging conforming to UN standards. For Class 9 airbag modules and seat-belt pre-tensioners the UN Number is UN3268. For 2.2 Hazardous materials the UN Number is UN3353.

**Li Battery the UN NUMBER is UN3090 or UN3091 if packed with or contained in equipment.**

**Packaging Groups:** A grouping according to the degree of danger presented by hazardous materials. Packaging Group I indicates great danger, while Packaging Group II indicates medium danger. Packaging Group III indicates minor danger. For air bag modules and seat-belt pre-tensioners are PACKAGING GROUP III.

**Lithium batteries are PACKING GROUP II.**

**EX Number or Product Code:** The word "Recycled" must be entered on the shipping paper.

**Li-ion Battery, 9, UN3090, II, Recycled, ? lbs**

**24-Hour Response Telephone Number:** HazMat shipper must provide a 24-hour emergency response telephone number such as INFOTRAC I -800-535-5053.

**Retention of Shipping Papers:** Shippers and carriers are required to retain shipping papers or electronic images thereof for a period of one (1) year to be accessible through their respective principal places of business.

### Safe Packaging Practices for Lithium Batteries:

The lithium battery or cell must be packed in "inner packaging" in a manner to prevent short circuits, including movement which could lead to short circuits. The inner packaging must be packed within outer packaging AND be equipped with an effective means of preventing external short circuits.



A lithium battery for transportation by motor vehicle to a permitted storage facility, disposal site *or for purposes of recycling* is an exception from the specification packaging requirements when protected against short circuits and packed in outer packaging conforming to general standards

Batteries employing a strong, impact-resistant outer casing and exceeding a gross weight of 12 kg (26.5 lbs.), and assemblies of such batteries, may be packed in strong outer packaging, in protective enclosures (for example, in fully enclosed wooden slatted crates) or on pallets. Batteries must be secured to prevent inadvertent movement, and the terminals may not support the weight of other superimposed elements. Batteries packaged in this manner are not permitted for transportation by passenger aircraft, and may be transported by cargo aircraft only if approved by the Associate Administrator prior to transportation.

Contact the hazardous materials or dangerous goods office of the carrier you plan to use, such as UPS, FedEx, or DHL. Certain carriers will require you to certify that you have complied with the U.S. or international hazardous materials regulations.

# Buying a Scrap Vehicle without a Title in Iowa Iowa NMVTIS Law

Consumers and community cleanup projects should benefit from the tool through legal and final means of retiring nuisance and abandoned vehicles without fear of identity or title fraud from legal loose ends.

Iowa Automotive Recyclers along with Automotive Recyclers Association (ARA) advocates for the responsible and accountable disposition of all total loss vehicles for either repair or end of life processing.

**The new rule also included codifying NMVTIS into Iowa law** to make it an Iowa violation for entities that are not reporting salvage vehicles once they have reached the five vehicle threshold for reporting requirements.

Further, ARA recommends that all efforts be taken to support the reporting of total loss vehicles to NMVTIS and the full compliance with NMVTIS requirements by all participants engaged in the sale and processing of salvage vehicles.

Although under-utilized, the National Motor Vehicle Titling Information System or NMVTIS has the ability to hinder title cloning and auto theft by making data from recyclers available to law enforcement officers. Unlicensed buyers of vehicles may be selling titles or Vehicle Identification Numbers from the salvage they acquire while leaving titles open by not reporting to NMVTIS nor the state DOT that the vehicle has reached the end-of-life status.

**af-fi-da-vit** [afə'dāvit] *noun*  
1. a written statement confirmed by oath or affirmation, for use as evidence in court.

ARA believes that all entities involved in the automobile dismantling supply chain should be required to report to NMVTIS, including: state motor vehicle titling agencies, tow operators, towing companies, auto recyclers, salvage yards, insurance carriers, scrap vehicle shredders and scrap metal processors, "pull- or pick-apart yards," salvage pools, salvage auctions and other types of auctions, and businesses and individuals that handle salvage vehicles, including vehicles declared a "total loss".

## Buying a Scrap Vehicle without a Title in Iowa Iowa NMVTIS Law

ARA supports state enforceability of NMVTIS and efforts to amend state laws that make participation in NMVTIS and an NMVTIS number conditions of licensure for all businesses *and individuals* who handle and process salvage and end of life vehicles.

NMVTIS and now the state of Iowa rule that requires entities to report to NMVTIS the status of salvage vehicles is one small but useful piece of information that law enforcement can easily compile to begin tracking sales to unlicensed salvage buyers. **These buyers are subject to the provision of reporting to NMVTIS once they surpass the five vehicle threshold.**

Total loss vehicles are assigned salvage titles once determined to be end-of-life per state definitions. These vehicles enter the NMVTIS system and the buyer is identified in the system when the sale takes place. Rebuilder vehicles are handled the same as in the past using the salvage theft inspection process to clear the hurdles to become roadworthy once again.

The vehicles destined to become parts cars and ultimately crushed for scrap metal can and should be designated at the time of acquisition as CRUSHED in the NMVTIS system. That eliminates having to report a vehicle as a PARTS car and then later as CRUSHED. It also kills the VIN in the system and thus stops the potential for illegal activity using the VIN of a salvage vehicle processed by a compliant business. Vehicles in the NMVTIS system that are left open ended can be scrutinized by enforcement to determine if they have been purchased by buyers that have exceeded the hobbyist threshold or become involved in other illegal activity. **For these reasons, it is important for licensed automotive recyclers to stay current on the NMVTIS reporting time frame.**

The best way to report is to use a batch upload process through a service provider using the salvage yard's inventory management system. For example, Auto Data Direct or ADD's NMVTIS upload tools are designed to help users fulfill the reporting requirement quickly and easily.

Two account types are available to suit any size business or upload volume.

Full Service accounts include individual vehicle entry, batch vehicle entry using a spreadsheet and business-to-business processing which can be arranged with the customer's IT staff, all for a low per-report fee. Basic Service accounts include no-cost individual entry and emailed confirmation receipts. [www.add123.com/jsi/salvage](http://www.add123.com/jsi/salvage)

The two components of the new Iowa law should work together to provide a legal means for individuals to sell their salvage vehicle without title to a licensed Iowa automotive recycler using an affidavit AND provide data to enforcement officers on those unlicensed scrappers that make up the black market businesses that operate without permits, licenses, and overhead costs of running a compliant business.

## Automotive Parts Procurement Growing in the Digital Arena

Technological advancements in the automotive industry are expected to greatly impact the aftermarket parts purchasing process.

According to a recently released report by Frost & Sullivan, a consulting firm which provides market research, analysis and growth strategy consulting, connected cars and the growth of urban and tech-savvy demographics will change the face of the automotive aftermarket model. E-retailing in the connected car world will become common place.



While the report states that it doesn't "... think the traditional distributor will ever go away" it added that "With so many new vehicles being sold in areas that lack distribution, the automotive industry is becoming the test case for how retailers meet the needs of a changing customer base. More and more of them live in regions that lack close proximity to an auto parts store." It is predicted that car apps will tell customers not only what is wrong with their cars but also direct them to service and parts providers.

The report also predicts that brick and mortar stores will contain much more technology to service the customer. Stores are expected to have self-serve kiosks, vending machines and virtual sales staff.



# ARA Updates

## ARA Secures Critical OE Part Number Data for Automotive Recycling Industry

On December 4, 2015, President Obama signed into law the Fixing America's Surface Transportation (FAST) Act legislation including the provision that **requires automotive manufacturers to provide original equipment (OE) parts data for recalled components**. ARA worked around the clock for months to secure this critical language in the bill.

When enacted, this new law will require automakers to make publicly available the OE part names, part descriptions and part numbers of a vehicle's defective components that are subject to a recall. **This is a significant step forward in ARA's quest for motor vehicle parts data**. At last, there will be federal statutory language mandating manufacturers to make OE part numbers available to the public. This language is a critical step as it provides a basis for ARA action in the coming months to work with regulators to secure electronic access to part numbers of re-

called components tied to Vehicle Identification Numbers (VINs). ARA will continue to educate policymakers that it is only with electronic access to part numbers associated with specific VINs that professional automotive recyclers can comply with the TREAD Act of 15 years ago in which Congress prohibited the sale of non-remedied recalled automotive parts.

ARA thanks supporters in Congress - most notably Congressman Adam Kinzinger of Illinois and Senator John Thune of South Dakota who champion the quest for this critical OE parts language. The bill includes other recall-related provisions that: calls for a pilot grant program for States to notify consumers of vehicle recalls, establishes incentives for dealers to check for open recalls at the time of service for all patrons and requires rental car companies to ground vehicles that are subject to an open safety recall until they are fixed.

## Steel Price Depression Has Huge Impact on Businesses

Historically low steel prices are the result of many factors and are having a significant impact on recyclers and many other businesses. Scrap steel prices are approximately \$50 per ton, down more than 70 percent from one year ago.

Reporting reasons for this decline include a downturn in the Chinese economy, a strong dollar which decreases exports, falling oil prices that depress the need for steel pipes by energy companies, record levels of cheap imports, a drop in the industrial and agriculture machinery market and excess supplies of metal commodities like iron ore. All of these factors have a ricochet effect on the auto salvage industry and beyond. Customers are getting less money when selling their cars to salvage yards and salvage yards are getting less money when they sell their scrap. Metal collection facilities, particularly in the automotive scrap business, are laying off employees and shuttering facilities. Some in the industry have noted that the price of scrap is so low that it doesn't pay for the fuel cost to haul auto bodies to scrap yards. Adding to economic woes created by low steel prices are the problems of industry consolidations and overseas competition in online automobile auctions.

Also, the increasing technical complexities of new vehicles are making home repairs increasingly harder to do. But some experts are cautiously hopeful that scrap prices will begin edging slowly back this year as national and global economies improve. They note the prices have reached as low as they are going to go simply because steel can't be manufactured any cheaper than it is right now.

In the interim, according to some scrap companies, **there are some things that auto recyclers can do to help counteract these low prices.** For example, whole cars can be sold versus hulls so auto recyclers can save time pulling motors, transmissions, wire harnesses, etc. A whole car contains 64% ferrous steel and 6 % nonferrous compared to 53 % ferrous and 2 % nonferrous for a hull. Auto recyclers can also look at scrapping cast iron, like in brake rotors and drums, transfer cases and clean motor blocks. Scrap companies noted that if cast iron is segregated, it can bring \$30 to \$40 more a ton over shredder feedstock. In addition, removing plastic bumpers, fenders and glass will also increase value as consistency of supply quality is critical.
